## Need-Based Tuition Assistance Application

Congratulations on being selected to be a singer with the Children's Chorus of Greater Dallas! Last season CCGD provided tuition assistance for 74 students enrolled in our Downtown Chorus. It is our goal to ensure that no one is turned away from CCGD because of an inability to pay complete tuition.

To properly process your application, please ensure that this application form is completed in its entirety. In order to receive priority consideration, **this application must be returned by Monday, July 1, 2017**. We recognize the sensitive nature of this information; everything collected by CCGD is held in the strictest confidence. The information requested pertains to the household where the singer resides and/or the person(s) who have primary responsibility for supporting the singer. The timeline for the Tuition Assistance program is below:

<b>JULY 1, 2017</b>	<b>Tuition assistance application due.</b> If you apply for tuition assistance, you do not need to pay a deposit at this time. Please mail all forms to: CCGD, 325 N. St. Paul St., Suite 2020, Dallas, Texas 75201.
<b>JULY 14, 2017</b>	Tuition assistance award notification letters are sent out via e-mail and post.
<b>JULY 28, 2017</b>	<b>Those receiving tuition assistance awards:</b> Tuition assistance contracts due to CCGD. <b>Those not receiving tuition assistance awards:</b> \$50.00 deposit due to CCGD.
<b>AUGUST 7</b>	Tuition not covered by tuition assistance award is due, unless the family enrolls in the CCGD payment plan. Tuition assistance awards typically range from 30% to 85% of tuition.
